#### 5. Network Provider Training

A. Contractor shall ensure that all Network Providers receive training regarding the Medi-Cal Managed Care program in order to operate in full compliance with the Contract and all applicable federal and State statutes and regulations. Contractor shall ensure that Network Provider training relates to Medi-Cal Managed Care services, policies, procedures and any modifications to existing services, policies or procedures. Training shall include methods for sharing information between Contractor, Network Provider, Member and/or other healthcare professionals. Contractor shall conduct training for all Network Providers within 10 working days after the Contractor places a newly contracted Network Provider on active status.

## Health Net Policy Explained



- New Provider= Newly contracted Medi-Cal physician, PPG, hospital, or ancillary service provider or a provider who's Medi-Cal contract with HN/CVH was termed over 30 days.
- Each newly contracted Medi-Cal site/location requires a training confirmation. Providers that have clinicians on site should have the highest level clinician(s) take the training.
- Non-clinician type of providers (e.g. labs) can have the administrator sign on behalf of the site.
- Signed Attestation= Training Confirmation
- <u>HN policy states that providers should take the training</u> and sign the attestation form before becoming active in the system or record.




